INTRODUCTION

SINCE King Akhenaten has started the idea of it is possible a Sidereal Illumination directly from the Great Central Sun to anyone sincere seeker looking for Eternal Life, Illuminism as a metaphysical matter has been developed continuously thorough the terrestrial centuries and comes today as some Public Monographs published on the Net by Ordo Illuminati Aegyptorum (Illuminates of Kemet): http://svmmvmbonvm.org/aum_muh.html

Sidereal Illumination is the core of SIB (Sidereal Illuminated Brotherhood), the Eternal and Universal Organisation that congregates Cosmic Masters as Summum Bonum Amen Ra (KMK), Apis Kemet (AWS), Aum-Rah (CM), K-G-P (OM) and others. These Masters are the operators of the Transformation Day for all planets in this Universe, including Earth. In a separate Public Monograph I have described exactly what is the Transformation Day and the deadline for this magnificent cosmic event is February 15th, 2034CE.

In order to introduce correctly this essay to R+C students and more it is necessary, first of all, to expose some KMT concepts on God. Normally, western esotericists thinks that Kemetic Religion (KMT) is polytheist and Pharaoh Akhenaten, the 98^o Nisut of Khem, was an heretic revolutionaire, imposing monotheism. It is not true. 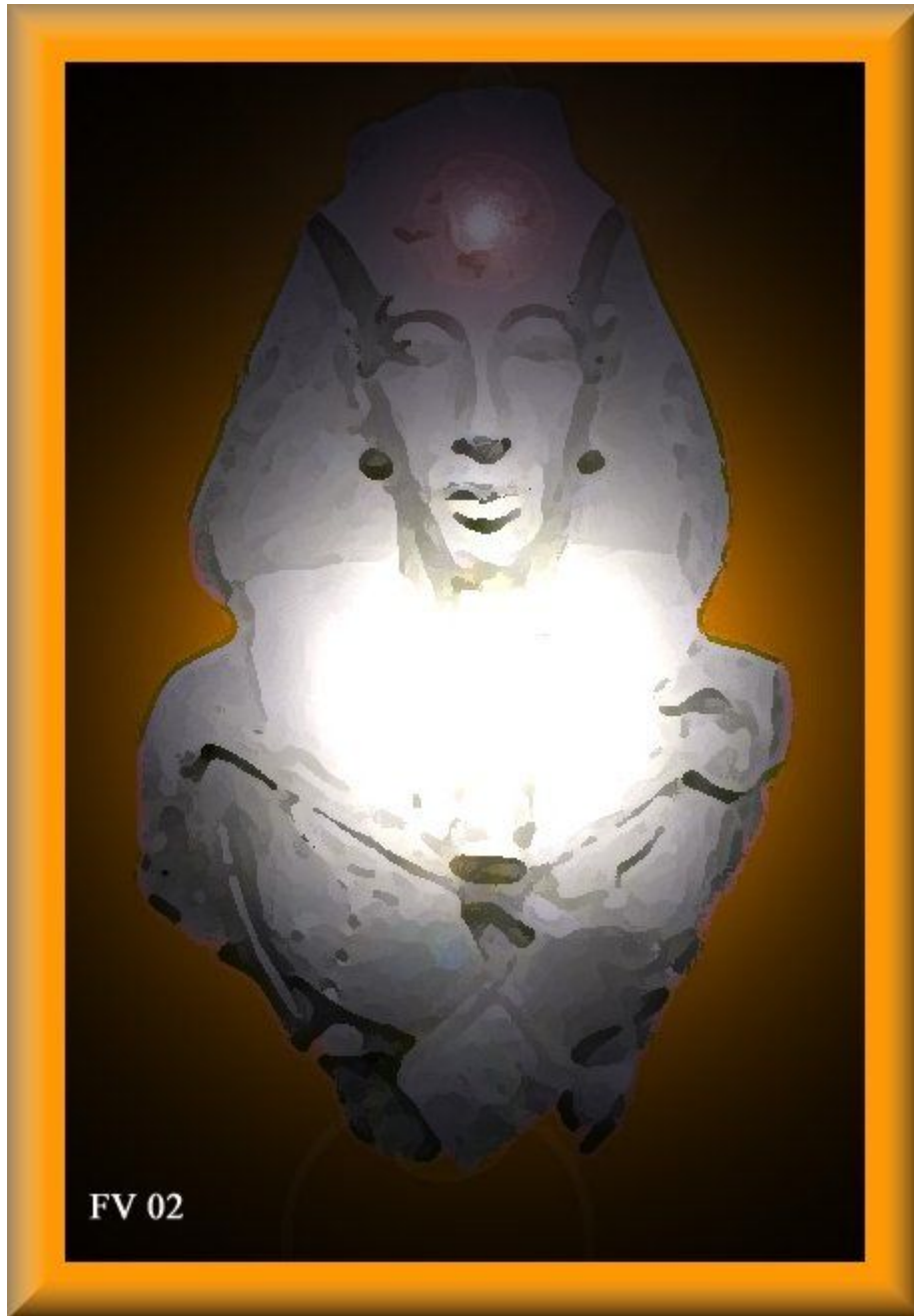
Neferkheperura Waenra Amenhotep IV (Akhenaten) was the 98^o Nisut of Kemetic Religion during a short period, because he founded the Monotheism in Ancient Egypt as a Grand Kheri-Heb of Aten, the Only Creator of Life on planet Earth, and changed his name from Amenhotep IV to Akhenaten. After taking control of the throne in 1346, Amenhotep IV transferred the city of rule from Thebes to a new city called Amarna (Akhen-taten). When Akhenaten journeyed to the Eternal Life the original Kemetic Religion was restored under the regency of Amun-Re (also the Sun God) with his complete pyramidal Pantheon of Gods and Goddesses, by the King Tut-Ankh-Amun. For a lot of members of KMT the revolution promoted by Akhenaten was just a heresy but this is a grand mistake, just because authentic Kemetic Religion ever was monotheist in its metaphysical essence. And this essence cannot be destroyed by priests or kings.

“Thus physically the Pharaoh was the human embodiment of the divine powers of the Nile and of vegetation, of life, death and resurrection of Osiris and Horus. Later on this concept was applied to mankind in general. Not everyman was truly Osiris-Horus as the pharaoh was truly so, but every man lived and died by virtue of the same divine vital forces and experienced the same renewal of life after seeming death. Thus human life and immortality were merged in the same process as natural and cosmic life and vitality. All other religions which originated in the Middle East were eventually affected and influenced by these beliefs.” (Rev. Dr. Kanefer Anpu Mubarak, 7Ph.D., in “KMT”, The Order of Maat, Inc., 2004CE).

Due the concept exposed above the Pharaoh is the te appropriate person to diffuse symbols of Eternal Light in this planet and just this was the great workmanship on King Aklhenaten. In another

One of most controversial, private and fascinating themes of the modern Rosicrucianism is the true nature of the Cosmic Masters. One knows that many of them had been people in this planet of pains and probations, but also of joys and accomplishments, the Earth. Others would be mental creations of mystics that if had crystallize (word that defines, in the Cosmic Plan, the equivalent the materialization in the Physical Plan) in the invisible dimension for the human eye; others, still, would be beings of planets that not the Earth, ascended to the condition of Masters in *post-mortem* (after death) it physical or transformed for this condition by

It becomes necessary, in this point, the insertion of a small preamble to the *Amorcus* subject , in which one will be to the *implied acceptance* and the *compulsory rejection* of certain facts in the mystical area. Generally, people accept as part of the reality those affirmations that are presented toall since his infancy, as example, can themselves be cited Adam and Eve, personages of the Jewish alegory on the creation of the Universe. Nowadays already it is proven, scientifically, that the first human couple was black and that lived in Africa, cradle of the humanity, where the melanin in the skin is part of the natural system of protection against certain solar effect very accented in that region of the globe. However, practically all the Christian occidental civilization person piously continues believing the Biblical version for the origin of the humanity; and practically all the occidental esotericists accept without pleas the metaphysical constructions presented in the Kabbalah. The ancient and modern occidental esoterism is based in the Jewish beliefs, the history of the Jewish people (that it is the Bible), and incorporates some superficial interpretations of the ancient Kemethic religion (the Egyptian pantheon of deities) and diverse principles extracted from Buddhism. Of this mixture of bedding, reflections, theses and dogmas the esoteric and initiatory orders and fraternities actually existing in the Occident was made with this mix, including the Rosicrucian organizations. The Bible has been the repository of the esoteric recital occidental person, in almost all the aspects. It is

seen, as example, the case of the crystallization of number 7 as very special mystical symbol: it is written in the Bible that God created the Universe through 7 days; the 7, then, passed to be had, to be consecrated and to be proclaimed as essentially esoteric, symbol of sacred content, endowed with indescribable properties magick-theurgical (if you I will be interested in the properties of the number 777 I invite you to click here to have access the page on the Celestial Sanctum (Cathedral of Soul) created by Dr. Harvey Spencer Lewis, in which this subject is boarded). Practically nobody argues this, questions or contests. Why? Because since small the people they listen to these affirmations. It is had there of that it consists the implied acceptance of the affirmations. Already the compulsory rejection consists of the automatic plea of that it seems to be strange. Thus, if somebody to say that have a vision of Our Lady or that "canalized" a message from Ashtar Sheram, or if somebody, presenting itself as paranormal, to take off gold coins of the beard, or, as medium, to receive and to give consultations with the spirit of Doctor X, carrying through operations with scalpel, much few will find odd, therefore this everything is part of the daily routine for all people. However, if somebody to affirm that was contacted by an Amorcus - help me, God! - he could be ridicularized, labeled as crazy or be contested as defrauding the mystical reality ("mystical reality "? I will have read right what I myself I wrote? Lord, mercy!!: what it will be, accurately, the mystical reality?!). Why? Because this name, Amorcus, forces to remember the Rosicrucian Order AMORC and all finds that this sounds strange. "An Amorcus! As this entity could exist, also preceding the physical existence of the AMORC in modernity! Ah, not, this is excessively " - would say the typical esoteric bureaucrat people, that personage that if leans over with its pairs on old books in vain attempt to assimilate something reading lines, when the teachings are in the space between these lines, that he simply cannot see, mainly due to petulance of that are inflated. Made this preamble, it is moment to enter directly in the subject of this modest essay.

Amorcus is a very special Cosmic Master solely accessible to the high initiated of the Rosicrucian Order and that not be invoked by anyone, including these graduated Rosicrucians. Amorcus, however, has the power to always convoke any one of these Members of the Inner Circle for a mission, appearing before them involved in a mystical white Light extremely shining , that forms an oval figure. Until where I am authorized to in general to express revelations in this particular one before the public, I can say that Amorcus is a Multimental Master, a type of Being Cosmic that few mystics know. He is an entity immortal, self-conscious, formed by the congregation in All-Are-One of the 39 immortal minds of 39 Illuminati, the ones that had been Members, in Ancient Egypt, of "The Illuminated", secret mystical school established pharaoh Akhenaten and that he consisted in the first nucleus of mystics with a line of thought that can be defined as Rosicrucian , even so at that time did not exist, still, this literal denomination for a mystical group. Amorcus is the Instructor who brings for modernity the Light of Ancient Egypt. Amorcus was the special Instructor of Dr. Harvey Spencer Lewis on many esoteric facts that had resulted in the organization of the Rosicrucian Order AMORC. However, only few mystics if would dare to approach this subject. The proper Dr. Spencer Lewis preferred not to go deep itself this subject very before profane people e, mainly, before the mediocre bureaucrats of the esotericism at this epoch, with his mystical Licenses, Authorization Letters and an extensive universe of documents manuscript or printed and that served, according to them, to certify the authenticity of any order, fraternity or esoteric school that came to be established demanding roots on this vacant and subjective word: Tradition. Dr. Spencer Lewis, pressured for this bureaucrats, criticized and contested for envious, that they could not support the success of the Organization that it constructs, answered, certain time, before a question on that transmits it the origins of the AMORC: "... was the Amorcus". Dr. Spencer Lewis wise person who when saying the truth this would be interpreted as trick and was thus that it said e to it, at the same time, occulted it

for the idiots, in a skillful action of only two words. Obviously his enemies had used them against he, mentioning this reply to it in some writings, all they absolutely imbeciles when seen through the mystical focus or same if read by somebody intelligent thing. It is important to remember here that the esotericism, in Occident, always was a hobby - and only this - for thousands of bored people desirous of personal affirmation.

As it was said here, the Amorcus is a Cosmic Master Instructor, but few persons can speak about his essence, therefore the complete study of his nature, his cosmic mission and the interaction of minds illuminated in his All-Are-One, forming the Inductive Unit, is substance reserved for who entered the Internal Sphere of the Rosicrucian Order. However, it is necessary to say that Amorcus *is only one eventual referential name* , not an *absolute denomination*, and that this Master although to be always the same and of if revealing as appearance always in the same way - involved in Light - he can present with some types of content and some forms of expression, as the circumstances, the level of harmonization and the necessities of understanding so that everything results in definitive mystical event. As example, I can say to you All that was this Master who appeared before Max Heindel, instructing he on the true mystical nature of the Cosmos - and in the occasion this Cosmic Master transmitted some on knowledge from Ancient Egypt, that the Founder of the The Rosicrucian Fellowship included in his revelations. Here it is because you go to find references the Horus, for example, in the mystical workmanship of an essentially Christian Rosicrucian philosopher based on the Bible as Max Heindel. In his text, Max Heindel relates to this Instructor as "a stranger being of the Superior Plane". He was also this Master Instructor, to who the Dr. Spencer Lewis if related as Amorcus, the person who orientates of some important mystics of the Golden Dawn and of other Rosicrucian schools of illumination for the soul.

1 - Ordo Illuminati Ægyptorum (Sacred Light from Kemet)

ORDO Illuminati Ægyptorum (OIÆ) a.k.a Illuminates of Kemet is the Official continuation, in the modernity, of the Authentic King Akhenaten's Mysteries School, from Kemet (Ancient Egypt). OIÆ is a secret Order reserved for R+C Adepts only (Senior Members from Inner Circle of various Ancient, Authentic and Traditional Orders and Fraternities based in Lux From Kem Sacred Principle (Sacred Light from Kemet). OIÆ is the most ancient Ordo Illuminatorum as the Illuminati (Illuminated) Great Work is known in Western Mysteries. The basical difference between the "modern" Illuminati Credo and the Kem's Illuminated's LVX Tablet is the metaphysical concept on the Triangle of Light. Illuminati from the Bavarian School has received from a secret Rosicrucian Order founded in Germany on 1614 CE the Sacred LVX Principle from KMT (pronounced Kemet) and adapted it to the social, politics an cultural realities existing in the XVII Century. Illuminatus Adam Weishaupt founded the Illuminati of Bavaria on May 1, 1776 on the principles of his early training as a Jesuit. Originally called the Order of the Perfectibilists. Freemasonry has imported some Illuminati Principles for to works aiming a better human society based in Justice and Equality as the two points of a Mystical Triangle generating Light such its third point. Weishaupt, revered by The Svmmvm Bonvm Organization as a Master of Light, was not then a Freemason; he was initiated into Lodge Theodore of Good Council (Theodor zum guten Rath), at Munich in 1777.

Basically the Illuminati Principles are coincident but the Mystical Triangle from Kemet differs because its three points are: Light, Life and Love - generating the square reality on Earth as Liberty with Responsibility for a better human society. These conceptions have been modified and adapted in Germany due the strongly influence of some currents from the powerful Romain Catholic Apostolic Church, principally from Jesuit Order. But because of Weishaupt's strong anti-clerical and anti-royalistic views, some have assumed that the Illuminati were some sort of proto-communistic organization dedicated to bringing about a proletarian revolution.

On the 18th Kemetic Dinasty the 98° Nisut, Neferkheperura Wa en Ra Amen Hotep IV (Akhenaten) and his 39 Adepts in the KMT Hermetic Order (a Monotheist Mysteries School) have been established the Angular and Basilar Philosophal Stone for the future foundation of various Rosicrucian Orders. The Golden Rosicrucian Principle (Roses flourishes on the Cross) is the same Kem's Illuminated Sacred Principle symbolized by the Lotus with human face on the Sacred Ankh as you can see here:



This transcendental Sacred Principle was not “created” by King Akhenaten, Prophet of Real Solar Disk. He just received it from the real Kem Founders, the Superior Beings from Spiritual Planet Uranus (Uranus2). These Beings have modified the DNA of some primates generating the human race.

Illuminati is a Greek word meaning Illumination a name given to those who submitted to Christian baptism. Those who were baptized were called Illuminati or Illuminated / Enlightened Ones by the Ante-Nicene clergy, on the assumption that those who were instructed for baptism in the Apostolic faith had an enlightened understanding. Many people believe that the Illuminati have been plotting to take over the world since the time of its creation. To me Illuminati does exist - an may in some form still exist. It is all part of the conspiracy games men play. The reality / program in which we exist has always been based on those who have the power and knowledge, those who say they do, and those who try to control it.

The energies for the creation of various secret societies, including Illuminati, as some Ordo Illuminatorum, goes back to the ancient priesthoods of Kemet (Egypt), when the sacred knowledge of Humanity's creation was hidden by those who sought control. They became the priesthoods. The Kem's Illuminated is the name of the Secret Esotericist School founded on the 18th Kemet Dynasty by King Neferkheperura Wa en Ra Amen Hotep IV, Akhenaten, 98^o Nisut of Kem. In the Modernity this hermetic order was preserved inside two initiatory fraternities: The Rosicrucian Order, Amorc, organized by Dr. Harvey Spencer Lewis, Ph.D., and Ordo Illuminati Ægyptorum, organized by The Svmmvm Bonvm Organization as the Kem's Illuminated Home for Highest Rosicrucian Initiated, the 7Ph.D. Adepts from the Pharaoh's Seventh Degree Initiation, online at:

1.1 - The Alumbrados

The Alumbrados, a secret 16th-century Spanish sect, were among the societies that subsequently adopted the name Illuminati. A mystical movement, at one time lead by La Beata de Piedrahita (d. 1511); first recorded about 1492 in Spain (a variant spelling, aluminados, is found in 1498). They believed that the human soul could enter into direct communication with the Holy Spirit and, due to their extravagant claims of visions and revelations, had three edicts issued against them by the Catholic Inquisition, the first on 23 September 1525. The name assumed by some mystics who appeared in Spain in the sixteenth century and claimed to have direct intercourse with God. They held that the human soul can reach such a degree of perfection that it contemplates even in the present life the essence of God and comprehends the mystery of the Trinity. All external worship, they declared, is superfluous, the reception of the sacraments useless, and sin impossible in this state of complete union with Him Who is Perfection Itself. Carnal desires may be indulged and other sinful actions committed freely without staining the soul. The highest perfection attainable by the Christian consists in the elimination of all activity, the loss of individuality, and complete absorption in God (see QUIETISM).

The peasant girl known as La Beata de Piedrahita (d. 1511) is cited among the early adherents of these "errors"; but it is not certain that she was guilty of heresy. At Toledo, which was one of the main centres of Illuminism, Isabella of the Cross is said to have carried on an active propaganda. More celebrated was Magdalen of the Cross, a Poor Clare of Aguilar near Cordova, who, however, in 1546, solemnly abjured the heresy. So rapidly did the errors gain ground that the Inquisition proceeded with relentless energy against all suspects, even citing before its tribunal St. John of Avila and St. Ignatius of Loyola. The Society of Jesus was founded by Ignatius of Loyola, who could be seen as the Catholic Reformation's equivalent to Martin Luther. Loyola was born Inigo

de Oñez y Loyola on 1491. He was born at his family's ancestral castle in Guipúzcoa. When he was old enough, he entered the military service, where he served until 1521 when he was seriously wounded in battle. During his recovery from his wounds, he read about the lives of the saints of the church, and he was motivated to devote his life to spiritual service. He hung up his sword and spent a year in prayer and meditation at a cave near the Manresa monastery. While there, Loyola fasted, knelt in prayer for seven hours a day, and flagellated himself to the point of endangering his health. Loyola later described this time as an incredible 'mystical' experience during which he had blinding visions of heaven and hell and Christ and Satan. He saw Jesus as "a big round form shining as gold."

In spite of this determined action, however, the heresy maintained itself until the middle of the seventeenth century and some of its features reappear in the Quietism of the Spaniard Michael de Molinos.

1.2 - Adam Weishaupt

Later, the title of Illuminati was used by a secret society founded in 1776 by Adam Weishaupt, a former Jesuit and professor of canon law at the University of Ingolstadt. It that aimed to combat religious thinking and encourage rationalism. Weishaupt was born in 1748 at Ingoldstadt of Jewish parents but grew up in the Catholic faith, educated by Jesuites. When his father, George Weishaupt, died in 1754, young Adam was turned over to be raised by the Jesuits by his godfather, Baron Ickstatt, who was curator of the university of Ingolstadt in Bavaria. He converted to Protestantism when studying law at Ingolstadt. He had also studied classic Religion and Theology and the Eleusian and Mithrian mysteries, and also the works of Pythagoras. We don't know much

about his childhood or his early life, and even his name itself is somewhat of a mystery. Adam Weishaupt founded the Illuminati of Bavaria on May 1, 1776 on the principles of his early training as a Jesuit. Originally called the Order of the Perfectibilists, "its professed object was, by the mutual assistance of its members, to attain the highest possible degree of morality and virtue, and to lay the foundation for the reformation of the world by the association of good men to oppose the progress of moral evil."(1) His appointment as Professor of Natural and Canon Law at the University of Ingolstadt in 1775, a position previously held by an ecclesiastic, gave great offense to the clergy. "Weishaupt, whose views were cosmopolitan, and who knew and condemned the bigotry and superstitions of the Priests, established an opposing party in the University.... This was the beginning of the Order of Illuminati or the Enlightened..."(2) Weishaupt was not then a Freemason; he was initiated into Lodge Theodore of Good Council (Theodor zum guten Rath), at Munich in 1777.

Adam means "the first man", "Weis" means "to know" and "haupt" means "leader", which makes Adam Weishaupt's name mean "the first man to lead those who know". He graduated from the University of Ingolstadt in 1768, and was made a tutor and catechist. In 1772 he was made a professor of Law. He was initiated as a Freemason in 1774 in either Hannover or Munich, but found that no one in his order truly understood the occult significance of the ceremonies. He decided to found his own organisation, which he did on the first of May 1776. This organisation was first known as "The Order of Perfectibilists" but became famous as the "Ordo Illuminati Bavarensis", or the Illuminati for short. Only five people were present at the first meeting of the order, but it grew rapidly and only a few years later it had chapter houses all over Germany, Austria, France, Italy, Hungaria and Switzerland. Weishaupt and his co-conspirators, notably Baron Knigge and a lawyer named Zwack, had soon established a network of agents around Europe that infiltrated

courts and other places of power and reported back useful gossip and information to Weishaupt. The Illuminati true goals were shrouded in mystery. Because of Weishaupt's strong anti-clerical and anti-royalist views, some have assumed that the Illuminati were some sort of proto-communistic organisation dedicated to bringing about a proletarian revolution. Others have seen them as anarchists, or descendants of the Cathars, or the Knights Templar and the Assassins of Hassan En Sabbah, the "Old Man on the Mountain", with whom the Knights Templar were rumored to be in contact with. Yet others have seen them as Satanic agents dedicated to nothing less than the domination of the planet and the bringing about of the Kingdom of Satan on Earth. It is true that Weishaupt's plans certainly was hostile to the Church of Rome and the monarchies of Europe, and that he seemed to harbor what would today be called "socialistic" leanings, but Weishaupt wasn't an atheist or agnostic. There is little doubt that Weishaupt was a deeply religious man in his own way. Weishaupt said in a speech held shortly before the French revolution;

"Salvation does not lie where strong thrones are defended by swords, where the smoke of censers ascend to heaven or where thousands of strong men pace the rich fields of harvest. The revolution which is about to break will be sterile if it is not complete."

This statement has often been taken as to mean that Weishaupt was in fact a sort of communist, and in a sense perhaps he was. One could think the above quote a statement by Trotski. However, as the Illuminati's true goals has always been disputed it is difficult to find out what exactly was the political, if such a dirty word may be used, or ideological *raison d'être* of the order. Of course, the easiest way to be able to make an educated guess is to study the actions of the order, as we will here. In the year 1784 the Illuminati attempted a coup against the Hapsburgs, but the plot was revealed by police-spies that had infiltrated the order on orders from the

king. This led to the total ban of all secret societies in Bavaria, and membership was punishable by death. This edict was signed in June 1784. Weishaupt was forced to flee to a neighboring province in February 1785 and in March another edict was passed, this one specifically outlawing the Illuminati. The Illuminati was forced to go underground in Bavaria and had to move its revolutionary efforts elsewhere. Disaster again struck for the order when in July 1785 lightning struck an Illuminati courier, a man named Lanz, and killed him and the horse he was riding. It is said that both Lanz and the horse was charred to coal, but the saddlebags were almost intact. In them was found extensive documents that outlined the Illuminati's plans for world domination and revolution, and also named several high ranking Illuminati members, among them Zwack and Weishaupt. Zwack was arrested and his home raided in October 1786. Weishaupt's activities after 1790 are disputed, several different versions of his life after 1790 exists. In Robert Anton Wilson and Robert Shea's famous trilogy *Illuminatus!*, for instance, it is suggested that Weishaupt traveled to America and assumed the role of George Washington. Others claim that Weishaupt died in obscurity in 1830. I have chosen to continue to try and trace the alleged influence of the Illuminati in the following years as it is possible, however unlikely it may seem to those who take a conventional view of history, that Weishaupt was directing things from behind the scenes. The French revolution of 1789 has been widely attributed to the machinations of the Illuminati, and its role has been described as everything from "negligible" to "sole cause". Both statements are an exaggeration, but it cannot be denied that several persons who were intensively involved in the revolution was active members, among others the Comte de Mirabeau, famous author, orator, Freemason and arch-enemy of the Marquis de Sade. Mirabeau is reported to have said in a speech at the international Freemasons convention in Wilhelmsbad in 1782 that he was a member of an organisation that was influenced by the Knights Templar, and that their goal was to destroy the Church and the monarchy so that the "Religion of Love" could be

established in France. Of course, the Illuminati was not the only secret revolutionary conspiracy around. There were plenty of others in these turbulent years just before the revolution. For instance, the Marquis de Luchet, who were opposed to the Illuminati but supportive of the revolution, said in a speech;

"There exists a conspiracy in favour of despotism, against liberty, of incapacity against talent, of vice against virtue, of ignorance against enlightenment. This society aims to govern the world."

These inner conflicts among those who supported the revolution was also seen in other secret societies in France during this period. By the year 1788 almost every lodge of Freemasons in Europe, as well as all courts, been infiltrated by the agents of the Illuminati. Despite this many of the established lodges in France remained loyal to the king, and only a few took part in the revolution. It is interesting to note that the very first time anyone saw revolutionaries wearing the Phrygian cap, supposed symbol of the Illuminati and the Phrygian mysteries, was at the forced interruption of a theatrical performance of *Le Suborneur* by the Marquis de Sade on Monday the 5th of March 1792. Oddly enough, no-one (except for a brief passage in Wilgus' *Illuminoids*) has to my knowledge suggested that the infamous Marquis was a member of the Illuminati. Sometimes it seems that every famous person throughout history has been pointed out as a member. It is like Ambrose Bierce wrote about the Freemasons in his *The Devil's Dictionary*;

"An order with secret rites, grotesque ceremonies and fantastic costumes, which originating in the reign of Charles II, among working artisans of London, has been joined successively by the dead of past centuries in unbroken retrogression until now it embraces all the generations of man on the hither side of Adam and is drumming up distinguished recruits among the pre-Creation inhabitants of Chaos and the Formless Void. The order was

founded at different times by Charlemagne, Julius Caesar, Cyrus, Solomon, Zoroaster, Confucius, Tutankhamun and Buddha. Its emblems and symbols have been found in the Catacombs of Paris and Rome, on the stones of the Parthenon and the Chinese Great Wall, among the temples of Karnak and Palmyra and in the Egyptian Pyramids - always by a Freemason."

The history of the Illuminati, or its supposed history as traced by various people, is much like Bierces' satirical comment.

Ludvig XVI, the French king, wasn't unaware of the revolutionary activities and general displeasure among the population. In June 1789 he tried to introduce some social reforms that he hoped would calm the population. The king's greatest mistake was when he demanded that the monarchy would be preserved and that the nobles were to retain the right of veto in all future reforms. This led to minor rebellions that spread and finally culminated in the taking of the Bastille. Mirabeau said in a speech shortly thereafter;

"The idolatry of the monarchy has received a death blow from the sons and daughters of the Order of the Templars."

This statement suggests that the Illuminati had ties to both the Cathars and the Knights Templar. Under the later period of the revolution the influence of the Illuminati becomes marked. The red Phrygian caps are used as symbol of the revolutionaries, the symbol of the Illuminati, the eye in the triangle, is present on many revolutionary documents printed in these days. Two years after Ludvig XVI failed escape attempt, on the 21st of January 1793, he was executed, and it is said that when the king's head fell an old man cried from the crowd; "De Molay, thou art avenged!" De Molay was the leader of the Knights Templar who was burned at the stake for witchcraft in March 1314 by the machinations of Philip the Fair and Pope Clement V. It should perhaps be mentioned that before his execution De Molay was held prisoner in

the Bastille, the first "victim" of the Revolution. After the French revolution the Illuminati faced new difficulties, partly because of the confused political and social situation in France, and partly because the rest of the royal houses of Europe panicked when they realized what had happened in France and banned all secret societies. Persecutions of Freemasons and Rosicrucians began, and in 1792 an ex-Grand Master of a Knights Templar inspired organisation was lynched in Versailles by an angry mob. Suspicion of all secret societies was widespread, and increased when Robinson's Proofs of a Conspiracy was released in 1798. This volume contained an outline of the orders supposed survival after its suppression as the German Union, and how it had engineered the Revolution. The book caused widespread fear in Europe and New England, and was one of the main reasons for the ban against secret societies in most of Europe. After the rise of Napoleon Bonaparte the days of the Illuminati in France were numbered. Most of the existing Lodges of Freemasons and other secret societies were infiltrated by the agents of Napoleon, who made sure to remove all possible subversive organisations in order to consolidate his power. Most conventional historians will argue that the Illuminati, if it survived at all after the events of 1785-86, now was utterly crushed. Historians of the more unconventional kind have argued that the Illuminati continues to thrive and influence the world even today.

1.3 - The Modern Illuminati

Knowledge is truly of the light - Illuminati - not meant to be control and bring fear - not meant to be hidden and revealed by the timetable of certain groups, but has always been there for humanity to see. It is about humanity's understanding that we are spirits / soul sparks from a greater source of light - Illuminated Ones - who

are having a physical experience in which they are seeking to find our spiritual essence.

These souls soon moved into Europe - again playing conspiracy games - the knighthoods developing - brotherhoods and other clandestine groups. Curious games. Yet the clues about who we are as a race - our inception and destiny were always there.

It would take till the 21st century for the truths to be revealed as human consciousness moves back into higher frequency and lower frequency emotions / game fail.

Europe has always been a place to play out the the games of royalty and power. Germany of course being the strongest pulse in the 20th century as Hitler made a bid for world power. He lost the game - at least in the reality in which I am writing this! Who knows what may have occurred in parallel realities?

Back to Germany...on its way into world domination..also with karmic ties to Egypt - as the souls are the same - they just moved out of Egypt of ancient timelines and into Germany in more modern lifetimes - same souls - playing new games!

The Order of the Illuminati was established with some unspecified ties to the Masonic lodges of Germany; as a secret society within a secret society, the Illuminati have produced at least as many myths as verifiable facts. The sympathies and beliefs of Weishaupt himself, for instance, have been claimed by countless groups -- Atheists, Cabalists, Rationalists, Democrats, Socialists, Anarchists. Some trace the Illuminati back to the Knights Templar, to Gnostic cults, to ancient Egypt, and even to Atlantis. In the 1790s, some credited (or blamed) the society with manipulating the American and French Revolutions. In the United States, Federalists encouraged people to believe Thomas Jefferson and the

Democratic Republican Party were controlled by the Illuminati in Europe.

It is not strictly necessary to disentangle fact from fiction, since the influence of the Order was greater in legend than in fact. But several things can be stated about the Illuminati with some degree of certainty. The two central figures in the organization were Weishaupt and Adolph Franz Friedrich Ludwid Baron Von Knigge. The Order promoted a belief in deism and a doctrine of spiritual perfection: the society was in fact first known as the Order of Perfectibilists.

1.4 - Some Illuminati Claimants

At their height, the Illuminati claimed over two thousand members, not only in Germany but in France, Belgium, Holland, Denmark, Sweden, Poland, Hungary, and Italy, including Goethe, Herder, and many other prominent nobles and reformers. But the Bavarian government cracked down on the Illuminati and other secret societies in 1784 for allegedly plotting a massive overthrow of Europe's monarchies, although it was unable to squelch them entirely.

Societe des Illumines d'Avignon: Formed by Dom Antoine Joseph de Perneti and the Polish Count Thaddeus Leszczy Grabianka in Avignon, France in 1786 (Kenning says 1787); later moving to Montpellier as the "Academy of True Masons". Although Kloss claims they were in existence in 1812, they would seem to have disappeared in the French Revolution.

Illuminated Theosophists or Chastanier's Rite: A 1767 modification of Perneti's "Hermetic Rite" that later merged with the London Theosophical Society in 1784.

Concordists: A secret order established in Prussia by M. Lang, on the wreck of the Tugendverein (Union of the Virtuous), which latter Body was instituted in 1790 [Miller says 1786] by Henrietta and Marcus Herz as a successor of the Illuminati [or Moses Mendelssohn]. According to Thomas Frost, *Secret Societies of the European Revolution*, vol. i, p. 183 [cited in *Occult Theocracy*, p. 377.] a second Tugendbund was formed by von Stein in 1807. It was suppressed in 1812 by the Prussian Government, on account of its supposed political tendencies, and was revived briefly between 1830-33.

World League of Illuminati: Allegedly the singer and journalist Theodor Reuss "re-activated" the Order of Illuminati in Munich in 1880. Leopold Engel founded his World League of Illuminati in Berlin in 1893. From these two sprung the Ordo Illuminatorum which was still active in Germany as late as the mid-1970s. Much research has been compiled by Peter-R. Koenig.

Illuminates of Stockholm: The Illuminated Chapter of Swedish Rite Freemasonry is currently composed of approximately 60 past or current Grand Lodge officers who have received the honorary 11th degree. It makes no claim to be related, historically or philisophically, with the Bavarian Illuminati and strictly speaking should not be included in this list.

Die Alte Erleuchtete Seer Bayerns: Alleged by Marc Lachance to have been founded in 1947 by employees of the Munich newspaper, *Suddeutsche Zeitung*, there are unsubstantiated claims to a longer lineage. With some 100 members claimed in Bavaria, Baden-Wurttensburg and Thuringia, they have disavowed ritual, and keep organised structure to a minimum. 29

The Illuminati Order: Founded sometime prior to 1988, Solomon Tulbure [1969/10/18 - 2004/11/17] brought this group online in

2001. Currently it can be found online at <http://www.illuminati-order.com>

Orden Illuminati: Another addition to the list of claimants to the Illuminati tradition, this group was founded in Spain in 1995 by Gabriel López de Rojas and can be found online at <http://www.ordeniluminati.com>

2 - Illuminatus CR+C, the Founder of Rosicrucianism

WHAT is really and exactly the Rosicrucianism? This is a crucial question for modern mystics and occultists, because the History reports the R+C foundation on the 16th Century and the principal Rosicrucian Order, AMORC, claims a R+C origin from Kemet (18^a Dynasty, by King Akhenaten). We entered the long awaited New Era (the Third Millennium CE) experiencing a lot of contradictions inside the kernel of the modern occultism and Rosicrucianism has specially affected. Several variations of Rosicrucianism was created by several esoteric people, including Tantric and Vedic versions. The image of Rosicrucianism as an ancient and traditional school of mystery has damaged by several unauthorized gurus, commercial enterprises using the name Rosicrucian, fools and a complete universe of irresponsible people using including the Net in order to construct the most fantastic and incredible Babel Tower involving Rosicrucianism. Unfortunately have not yet a serious control on the Net and all people can writes and publish dozens of pages containing the most absurd versions about all themes around the occultism. In essence, the Rosicrucianism is just a Cosmic Christic doctrine, based under the Divine Ethics, devoted to promote the continuous evolution of the human conscience. A doctrine method, based in ethics, aiming the self development of a kind of superior consciousness. No doubt, on this matter the AMORC system is the most enhanced and improved. Dr. Harvey Spencer Lewis, Ph.D., FRC (Master Alden), author of dozens of mystical books, essays and articles, wrote personally all Monographs for Temple Degrees and idealized the Planes (Superior Studies, reserved to the Members of the Sacred Esoteric Hierarchy) of AMORC, harmonized with the Masters of the Invisible Rosicrucian Order.

He goes to the Absolute at August 2 (Wednesday), 1939, in San Jose, CA. His cinder was entombed under a Memorial Triangle in the Rosicrucian Park. As an Ascended Master of the Great White Brotherhood Lodge (G.'W'.B.'L'.) founded in Tibet by our Venerable Founder, Kar-Gya-Pa, Sar Alden is one of the 12 (13) Masters of Ordo Svmmvm Bonvm: Master S-A. To define the importance of Master Alden not only in the modern Rosacruianism, but as one of the most important figures of the universal mysticism, leaving Century 20 for the Third Millennium as an authentic lighthouse of the New Era, it is necessary to speak of his principal mystical and alchemic workmanship: the creation and the elaboration of a plan of gradual studies destined to transform the common man in a better creature, spiritually superior, a Master of the Life. Just in this condition the Rosicrucian student assumes himself as an Illuminatus and this is an official Degree in the AMORC Hierarchy.

The Rosicrucianism will better have preponderant action in the transformation of the current human society in something better (under the point of view of the Real Ethics) as part of the natural evolution, a process in continuous course in the Universe, as I have exposed in a separate public monograph about Master Alden, wrote for Illuminates of Kemet. When it is said here in Universe not only understands the set of everything that is visible to the eye of the man, but yes the set of all the Plans of the Creation, visible and invisible, perceivable and imperceptible.

When people talk about the Rosicrucian Order - and in these modern times, with the advent of the Internet, it is accessible to all by a simple query on any search engine - the first image that comes to the mind of the public is of a secret - or in minimum reserved and private - society, involved with magick, that realizes rituals

and manipulates supernatural things. In the truth, the Rosicrucian Order is a private, closed society in an Inner Circle absolutely protected against invaders, to which the profane ones by no means has access, coated for an accessible External Circle to all. This External Circle functions as a species of filter and inside of it initiations are conferred and the Rosicrucian principles are placed in practical in the social conviviality between fratres (mystical brothers) and sorores (mystical sisters) in units that congregate them. Thus, in the Rosicrucian Order, AMORC, the Pronaoi, the Chapters (bigger) and the Lodge exist (bigger still), where this experience is tried. I mention AMORC here in my condition of its Member for Life, affiliated to the Grand Lodge of the Jurisdiction of the Portuguese Language (GLP), under Grand Masters Maria A. Moura and Charles Vega Parucker.

However, to be Rosicrucian does not only mean to belong to this or that Rosicrucian Order - several exist -, and it is not enough to have read this or that book on the subject, or same to have academically studied such or which monographs or any another type of pamphlet. In the truth, being Rosicrucian is to have a line of Rosicrucian thought (investigative and alchemist). The system of education of the AMORC, originally conceived for the I Emperor Dr. Harvey Spencer Lewis, aims at accurately to this: to form Rosicrucian minds able to mold new ages. Originally this system was a series of 12 Degrees of Temple, preceded for 3 Degrees of Atrium, for probation and acclimatization of the neophytes admitted to the studies of the Order. All Rosicrucian studies are secret and a correct member never can shows monographs, photos, schemes or another item to profanes or not graduated members. The two final Degrees were most extensive, with 167 monographs in the Eleventh and 325 monographs in Twelfth. When reaching monograph 32 of the Twelfth Degree the student entered the Esoteric Hierarchy and there, then, its preparation started, again as neophyte, for the access to the Internal Circle, through the study now already not in Degrees, but in 7

Planes. In the center of everything this is the Sacred True, Invisible and Eternal Rose+Cross, protected for one another Order, with another name. All this process of ascension was conceived by Master Alden to complete itself in about 25 years, if the student did not fail one alone day of prescribed study. It determined that these studies were carried through weekly, in the Thursday at night, preferential for return of 19h, by mystical reasons that are of the knowledge of the members of the Inner Circle.

The Rosicrucian study, as he was explicit explained by the Emperor Dr. Harvey Spencer Lewis (a.k.a. Frater Profundis XIII), of happy memory, is not an academic study, something that can be assimilated by the reading mechanics associated with the logical reasoning, as a technological substance. This kind of study is a mystical adventure reserved only for sincere seekers, a highly subjective study, illuminated by the Invisible Masters. The student must create himself his Inner Master and project it into the Inner Circle of the True Rosicrucian Order, inside the Great White Brotherhood Lodge (G.'W'.B'.L.'), where the Real Founder of this School of Illumination can be encountered: the mind of Akhenaten. To undertake it of the form established in the memorandum of understanding, unprepared, would be as if somebody intended to read the "Ulysses" of Joyce in another language that not that peculiar Irishman of Dublin, or either: without understanding the Irishman of Dublin it would be simply impossible to catch the literary sensations that Joyce placed there; or still, pure and simply to read of academic form monographs of the Order it would be as to look at for a picture of Paul Cézanne without being prepared for this (for an artistic-pictorial minimum of background). Cézanne innovated the painting of one such form that it introduced in the a "pictorial sensation": to if appreciating a screen its can not only be seen the workmanship pictorial but also "to feel it". Summarizing: when a prepared person looks at for a picture of Cézanne can accurately feel the same sensation that Cézanne was feeling when painting that workmanship. Spencer Lewis

introduced this type of thing in his system of mystical studies and recommended to all students do it in his reserved personal Rosicrucian sanctuary (Sanctum). Or either: subjectively, you when studying a monograph will be able to feel what the author was feeling when wrote it e, consequently, will have access to the same source inspiration. Here it is because Spencer Lewis recommended that the monographs were studied always in the Sanctum, in ritualistic style, and not chores as simple lessons of orthodox Philosophy. You can form a philosopher, not make a mystic, because this has of being auto generated.

Using this form, in the monographs of the Order Rosicrucian AMORC the teachings are given doubly: a) of objective and interactive form, including experiments that aim at to the development of certain psychic conditions, which, exactly, goes to allow the opening of that of Aldous Huxley called "the doors of perception" (that is only made here without the use of drugs) and b) of highly subjective form, with a reading before in the space between lines of text the one that in the lines - and is exactly this sophisticated form that characterizes as only the Rosicrucian study, because exactly the deeper study theological, including the dogmas, it is essentially objective, and is necessarily in this particular one that the Order if differentiates viscerally of the religions. The proper one is St. Thomas Aquinas was emphasized logical, and only in St. Benedict we see expositions subjective, of effect to subliminal, in such a way thus that it has numerous commentaries to the Holy Rule; note that Benedict he was not only a man of saint life, that the Church had decided canonize, but its sanctity was not in dependence of this; as much that operated miracles proven and on its words was constituted an Order that have 1740 years more than comes if keeping complete as in the origin; father of monks of the Occident, Blessed always fought - and he was successful - the Evil.

The process destined to the simple formation of a Rosicrucian thinker was the duration in minimum of a fourth of century and never was a mere academic study, that could be taken the handle for common reading of monographs. In the reality, the true teachings were not printed matters in the monographs, but they lay occult in the space between lines and alone they could be perceived through the ritualistic study, in the private Sanctum of each student. The methodical and untiring exercise of the experiments considered, awakening psychic centers until then sleep, enabled Rosicrucian student of the AMORC to harmonize himself with the occult teachings of the Invisible Masters of G.'W'.B'.L.'. These teachings enabled the student to enter the Internal Circle and there it would have:

1 - To think for proper itself as Rosicrucian, adding new knowledge - and new esoteric properties - to the Sacred Rosicrucian Egregore, that are not static, but essentially dynamic, dialectic and in continuous elaboration and refining;

2 - To act as Rosicrucian in the molding of new forms of manifestation of the Being in the Planes Physical, Mental and Abstract, with the opening of new doors of the perception for exclusively Metaphysical ways, resulting in subliming of the Art and Science.

As result of these two conditions - and performances - preliminary the closing of the Law of the Triangle was had:

3 - The student got nothing more nothing less than the Mastery of the Life .

The Mastery of the Life consists, then, as it is seen, in living not under control, but in the control, with definite destination and established intention, and not more as a vessel to the flavor of the winds and the squalls. That one that thus lives is not alone the

agent of the Rosicrucian Alchemy in some plans but also its patient, equally in some plans of understanding and having the control of this process. That one that it got the Mastery of the Life can, between some things, to decide if reincarnates as the continuation of a specific line of thought, also defining as it will be its new personality, for the achievement of a goal. As also it can decide to go for the Eternal Life. When one thinks that the almost absolute majority of the Humanity to the end of the terrestrial life will be simply recycled in the crucible of the Absolute Nothing (Nirvana), without that each unit of manifestation of the Being can decide its destination with autonomy, has measured it of the importance of the Rosicrucian Studies developed and organized by Master Alden, now living inside the G'.W'.B'.L.' as Master S-A, Master of Sacrosanctae Ordo Svmmvm Bonvm. Through these studies the man, without losing the condition of bee of the beehive, the collective conscience of it becomes simultaneously.

But after all, they would ask, what it accurately comes to be this line of Rosicrucian thought, that can involve so long preparation, normally 25 years, as already it was said? The Rosicrucian thought is not conventional academic and nor, is not imprisoned to the logical human being and also he is not subjective, because, in the truth, it functions according to a new type of objectivity. It would be difficult, practically impossible, to pass this accurate concept for a layperson, but it can be said, of a simplified form, that the Rosicrucian thought does not analyze the Creation of one mere terrestrial point-of-sight, human. The man conceives God as being a Being endowed with mind and of intention, that is, to he conceives-He it molds-The to its image, when God is not being, intention does not have mind much less, exactly for not being circumscribed to the time, as the man, who has start and end and looks for to give sensible to these colon joining them (when he makes it) for an performance line, that it aims at to a result to justify same itself, forming there the intention . The Rosicrucian thought sees the creation of a situated point of view above of this

platform beginning-intention-end . E is for this reason that one that acquired this vision has the Mastery of the Life.

And the Members of the Inner Circle, what they make they? Many leave of the mundane conviviality to dedicate the works special in favor of the Great Workmanship; others goes to work - or they continue working - in the scope of the External Circle, in functions generally apparently secondary and not if disclose, of form best to be able to act together to that are if initiating All, however, have in common the objective to become the world best, with more peace, health and prosperity, projecting in the future a society with raised level of conscience more and searching in the past inspiration to make it. Dr. Harvey Spencer Lewis was a man whom it knew to make this with rare property and such proficiency that it was consecrated in authentic genius of the Mysticism. The string is very tenuous that separates to the Mysticism of Science and in this New Millennium these two sources will be perfectly unified. The work of the Master Alden as Spencer Lewis, producing the Rosicrucian Study, is without a doubt some one of the bases for this extraordinary symbiosis that will illuminate the New (Mental) Era. This includes the inner encounter with the Real CR+C – the Eternal Illuminatus Cosmic Christ.

According Max Heindel, founder of The Rosicrucian Fellowship, Christian Rosenkreuz is a real personage, not a product of mystic fiction. I agree. Also for me CR+C is a real personage and his tomb is opened when is necessary. Now, his tombstone is open once again. Note that the Real CR+C is a Solar Logos that emanates personifications and living symbols, as Avatars like Budha and Jesus Christ. Remember: Our Lord Jesus Christ was educated in Egypt. Rosicrucianism is also a Light from Egypt and Kemet was founded by Cosmic Masters from Fourth Dimension planet (Uranus2).

On the beginning of the Third Millennium CE I've wrote and published in the Svmmvmbonvm.org domain an essay about Christian Rosenkreuz including texts extracted from books published by religious organisations that shows CR+C and Rosicrucianism as "a fraud". As a person from Catholic faith (I was benedictine monk during eight years) I cannot accept these versions because are not according with Jesus Christ message. If Christian Rosenkreuz is a real or an invented personage is not important. For me, his history have a mystical and occult significance that is not accessible for profanes (atheists or religious).

According the CR+C's documents, the amount of historical research into the phenomenon known as Rosicrucianism has been considerable over the past decade. Any number of published works on the subject almost unanimously focus their attention upon the 16/17th Century European foundation of the traditional Order. These works point out that the Invisible Order was founded in Germany, several centuries earlier, by an individual known as Christian Rosenkrutz. It is said that in order to perpetuate an ancient tradition he had initiated a few brothers into the mysteries of the Rose Cross. The successors to these brothers brought to light the existence of the Order in 1614, with the publication of the first Rosicrucian manifesto *Fama Fraternitatis*. However, the actual foundation of the Order is believed to have taken place on the occasion of the opening of the allegorical crypt of Christian Rosenkrutz, ten years prior to the publication of *Fama Fraternitatis*.

Although historically the foundation of the Order was in the 17th Century Europe, there is a considerable discussion among scholars on the traditional roots of Rosicrucianism. The name Rosicrucian is derived from the Latin: 'rosae' and 'crux' popularly translated to mean the 'rose cross'. Historically, the R+C (Rose Cross) has had both an outermost public interpretation, as well as an inner, hidden meaning, derived from less known sources. Its symbolic

significance is the key to understanding the intentions and objectives of Rosicrucianism.

I strongly encourage all students of esotericism really interested in Rosicrucianism to read the document Manifestations of the Neo-Rosicrucian Current by Frater Melchior, FRC, illustrated by me: <http://svmmvmbonvm.org/neor+c/>

The first Rosicrucians took their name from a fifteenth-century visionary and magician named Christian Rosenkreuz. Legend has it that after a long stay in the orient, he returned to Germany to found a monastery in which he sought spiritual fulfillment through isolated meditation and prayer. Spiritual disputes with Lutheran doctrine led the early Rosicrucian societies to follow in Rosenkreuz's hermetic footsteps, developing as enclosed orders of men sharing a unique set of mystical beliefs. In the 18th century, these groups turned towards alchemy and esotericism in order to distance themselves from the religious beliefs of the majority, basing many of their ideas and images upon those drawn from the Kabbala and the Freemasons.

According the Encyclopaedia Britannica, the origins of Rosicrucianism are obscure. The earliest extant document that mentions the order is the Fama Fraternitatis ("Account of the Brotherhood"), first published in 1614, which may have given the movement its initial impetus. The Fama recounts the journeys of Christian Rosenkreuz, the reputed founder of Rosicrucianism, who was allegedly born in 1378 and lived for 106 years. He is now generally regarded to have been a symbolic rather than a real character, whose story provided a legendary explanation of the order's origin. According to the Fama, Rosenkreuz acquired secret wisdom on trips to Egypt, Damascus, Damcar in Arabia, and Fès in Morocco, which he subsequently imparted to three others after his return to Germany. The number of his disciples was later increased to eight, who went to different countries.

In the late 1880's, the French critic and author Joséphin Péladan agreed to meet with the occultist Stanislas de Guaita. Guaita was initially attracted to Péladan's somewhat popular aesthetic novel, "Le Vice suprême", desiring to speak with the author of this original work. Sharing a disdain for common religion and society, the two men decided they would try to revive Rosicrucianism as a way to propagate their ideas. After a time, they separated over differing aims; Guaita was focused on the unorthodox elements of the society while Péladan attempted to set it apart as a Symbolist-Catholic entity of artistic truths.

Thus, Péladan's group broke off to form the international Salon de la Rose + Croix, with a manifesto written to proclaim the order's somewhat occultist ideals of art, accepting works dealing directly or indirectly with "Catholicism and Mysticism, Legend, Myth, Allegory, the Dream, the Paraphrase of great poetry, and finally all Lyricism..." Péladan's aim was "to tear love out of the western soul and replace it with the love of Beauty, the love of the Idea, the love of mystery." Some artists connected with his group, whose works were found "worthy" of being exhibited in the Rose + Croix salons, ranged from Jean Delville, Fernand Khnopff, to Alexandre Séon and Alphonse Osbert.

According Hermann Gruber, the original appellation of the alleged members of the occult-cabalistic-theosophic "Rosicrucian Brotherhood", described in the pamphlet "Fama Fraternalitatis R.C." (Rosae crucis), which was circulated in MS. As early as 1610 and first appeared in print in 1614 at Cassel. To the first two additions were prefixed the tract "Allgemeine und Generalreformation der ganzen weiten Welt", a translation of Fr. Boccacini's "Dei Ragguagli di Parnasso", 1612. Beginning with the fourth edition in 1615, the third Rosicrucian rudiment, "Confessio der Fraternalitat", was added to the "Fama". According to these, the Rosicrucian

brotherhood was founded in 1408 by a German nobleman, Christian Rosenkreuz (1378-1484), a former monk, who while travelling through Damascus, Jerusalem and Fez had been initiated into Arabian learning (magic), and who considered an antipapal Christianity, tinged with theosophy, his ideal of a religion. Concerned above all else that their names should appear in the Book of Life, the brothers were to consider the making of gold as unimportant-although for the true philosophers (Occultists) this was an easy matter and a parergon. They must apply themselves zealously and in the deepest secrecy to the study of Nature in her hidden forces, and to making their discoveries and inventions known to the order and profitable to the needs of humanity. And to further the object of the said order they must assemble annually at the "Edifice of the Holy Spirit", the secret head-quarters of the order, cure the sick gratuitously, and whilst each one procured himself a successor they must provide for the continuance of their order. Free from illness and pain, these "Invisibles", as they were called in the vernacular, were supposed to be yearning for the time when the church should be "purified".

For two hundred years, while the world never had the least suspicion of their existence, the brotherhood transmitted by these means the wisdom of "Father" Rosenkreuz, one hundred and twenty years after the latter's burial, until about 1604 they finally became known. The "Fama", which effected this, invited "all of the scholars and rulers of Europe" openly to favour the cause, and eventually to sue for entrance into the fraternity, to which, nevertheless, only chosen souls would be admitted. The morbid propensity of the age for esoterism, magic, and confederacies caused the "Fama" to raise a feverish excitement in men's minds, expressed in a flood of writings for and against the brotherhood, and in passionate efforts to win admission to the order, or at least to discover who were its members. All of these endeavours, even by scholars of real repute like Descartes and Leibniz, were without results. From the manifestly fabulous and impossible "History" of

the brotherhood, it was apparent that it depended upon a "mystification". This mystification was directly explained by an investigation by the author, who appears unquestionable to have been the Lutheran theologian of Württemberg, John Valentin Andrea (1586-1654). According to his own admission, Andrea composed in 1602 or 1603 the Rosicrucian book, "Chymische Hochzeit Christiani Rosenkreuz 1459", which appeared in 1616. This book, called by Andrea himself a youthful literary trifle in which he intended to ridicule the mania of the times for occult marvels (Life, p. 10), bears the closest intrinsic relation to the "Fama", which, in the light of this, is undoubtedly a later work of Andrea's or at least of one of the circle of friends inspired by him. Alchemistic occultism is mocked at in these works and in the "General-Reformation", the follies of the then untimely reformers of the world are openly ridiculed. The fantastic form of the tracts is borrowed from contemporary romances of knighthood and travel. The "Rosy Cross" was chosen for the symbol of the order because, first, the rose and cross were ancient symbols of occultism and, secondly, occur in the family arms of Andrea. It recalls Luther's motto: "Des Christen Hertz auf Rosen geht, wenn's mitten unter'm Kreuze steht" (Hossback, 121). As a result of his satirically meant but seriously accepted works, which soon gave rise to occult humbuggery (opposed by him) in new Rosicrucian raiment, Andrea openly renounced Rosicrucianism and frequently referred to it as a ridiculous comedy and folly. In spite of this, the Rosicrucian fraud, which served in many ways as a model for the anti-Masonic Taxil-Schwindel, has continued effective until the present day. In the seventeenth century Michael Maier and Robert Fludd were its champions. Psuedo-Rosicrucian societies arose, falsely claiming descent from the genuine fraternity of the "Fama". After 1750 occult Rosicrucianism was propagated by Freemasonry, where it led to endless extravagant manifestations (St. Germain, Cagliostro, Schropfer, Wollner etc.). In the system of high degrees in "Scottish" Freemasonry, especially in the Rosendruetz degree, the Rosicrucian symbols are still retained with a Masonic

interpretation. Finally, since about 1866 there have existed in England and Scotland (London, Newcastle, York, Glasgow) and in the United States (Boston, Philadelphia) "colleges" of a Masonic Rosicrucian society, whose members claim to be direct descendants of the brotherhood founded in 1408. Only Master Masons are eligible for membership. According to the definition of the president of the London branch (Supreme Magus), Brother Dr. Wm. Wynn Westcott, M.B., P.Z., it is "the aim of the Society to afford mutual aid and encouragement in working out the great problems of life and in searching out the secrets of nature; to facilitate the study of philosophy founded upon the Kabbalah and the doctrines of Hermes Trismegistus, which was inculcated by the original Fratres Roseae Crucis of Germany, A.D. 1450; and to investigate the meaning and symbolism of all that now remains of the wisdom, art, and literature of the ancient world". The view which has been lately revived, especially by Katsch and Pike, that Rosicrucianism definitely or even perceptibly cooperated in the foundation of modern Freemasonry in 1717, is contradicted by well-known historical facts.

Paracelsus, a Swiss alchemist who died in 1541, is also regarded by some as the real founder of Rosicrucianism. Others, however, view 16th- and 17th-century developments as simply a revival of the order and contend that Rosicrucian doctrines not only flourished in ancient Egypt but were espoused by such outstanding philosophical and religious figures as Plato, Jesus, Philo of Alexandria, Plotinus, and others. There is, however, no reliable evidence to date the order's history earlier than the 17th century.

3 – The Force and Illuminism (A Magical Rosicrucian Theory)

“FOR The Force never existed an origin.” This is the most hermetic, sacred and powerfull R+C principle for all Rosicrucian studentsreally interested in develops his Inner Masters. In order to understand completelly this principle, in its absolute essence, a lot of years of sincere and devoted studies are needed. The Force simply extracted itself from the Eternal Zero, generating conditions for the Creation, including Creator, Originator, all Universes, all beings. Then the Duality was materialized: He-She-It in the Minor Circle, the reflex of the Eternal Circle, the Absolute Zero. Thus the Vortex has been created.

The Force is just that all people names God. But, what exactly The Force is? For some mystics The Force simply cannot be described in human parameters, because The Force do not exist into these parameters, mentally created by men. Some people make confusion between The Force, the Eternal Light and the Cosmic Mind, introducing a pantheist scheme into modern metaphysics. The crucial problem on this matter is just philosophy cannot be used in order to analyse these conceptions. Only using mystic vision a common man can concept in his mind what is The Force, what is the Eternal Light, what is the Cosmic Mind. When a mystic can use this vision, this mystic is an Illuminatus.

We, Rosicrucians, know that The Force is essentially creative: he/she was extracted himself from the Eternal Zero and using the Eternal Nothing created all Universes, all Planes, all Spheres, all animated and unanimated creatures. Creation is the focus for the Eternal Eye. Thus, only analyzing the Creation - in a global

analysis - human creatures can intend understand what The Force is.

Reiterating, "For The Force never existed an origin." The Force simply extracted itself from the Eternal Zero, generating conditions for the Creation, including Creator, Originator, all Universes, all beings. Then the Duality was materialized: He-She-It in the Minor Circle, the reflex of the Eternal Circle, the Absolute Zero. Thus the Vortex has been created. The Vortex contains all information needed for the study of the truth about the Creation. Mystics yet prepared by traditional organizations as the Rosicrucian Orders and Fraternities (in the Superior Degrees) can to proceed the Vortex Invocation.

A very common mistake is a person thinks that The Force is essentially good. No. The Force is not good and is not bad. These opposites are just attributes of the Duality, the material and immaterial conditions where the Creation expresses Light and Mind as emanations from The Force. During the eternal creative process (it is an action permanently developed into a symbolic circle) The Force generates the Dual Concept because his primary condition is also dual: there are a Zero and from this Zero the number One was extracted. Then, the Zero is a kind of "starting point" for the One and this movement generates the illusion called Time.

"Time Conducting Entropy" is the second most important principle for for sincere seekers, because all of them are walking on Universes under the Law of Entropy and Time is the owner of his lifes.

Then in the Creation has been created the phenomena called Entropy, the Cosmic Law/Action that dissolves gradually entire universes inside the Time. This process occurs inside a minor symbolic circle, that is only the reflex of the Big Circle where The

Force is at the same time the central point and the circumference. The perfect comprehension of this question is the central point of human evolution. Evolution, for men, is just to obtain control on the minor entropic forces, for preserve individual existences as eternal individual beings.

How can a mystic take control on Entropy? Well, it is the fundamental question in an authentic progressive process of studies. This process is not a simple initiatic path, embodying mental ascension through several in a mystical scheme organized by an initiatory school as some Rosicrucian methods of teaching. This initiatic path - note! - is only the starting point for the "human circle", exactly the process of the Creation is a circle for The Force (!!). Magickal ceremonies, mystical ways of life, authentic Initiations are important pieces in the complete scheme for the construction of the Inner Master for all Adepts. Only for a example: in the Rosicrucian scheme for ascension of consciousness the "starting point" will be unleashed after 25 years of profound and devoted ritualistic studies.

When the starting point is finally unveiled for the student, a giant door for the Cosmic is opened. The student now is an authentic Adept and can see in a more accurate manner some evidences of the Presence of the Force. At this point the student knows that The Force really is not God as God is mentally created by human creatures. In this stage also the Law of Entropy can be comprehended, through its relation with the Time. Entropy only exists inside the minor circle where Time is imprisoned. Inside this circle the events occurs and segments of the Life are beings, just as human creatures. Outside this circle Life is eternal and the Law of Entropy simply cannot prevail.

The mind of the Rosicrucian student must be very starting in order to perceive the differences between the minor circle (where the human life exists) and the Eternal Circle (where Life is eternal).

Light is just the Mystical Bridge between these two circles; but Light, here, is not the physical light, as the light generated by the central star of the planetary system called Solar System. Light, here, is the Light generated by the Real Central Sun and diffused on planetary spheres of this Galaxy by the Cosmic Christ.

Who exactly is the Cosmic Christ? A magnificent universal image of the Ascended Jesus Christ? A magnificent universal image projected "inside" the Nirvana by the Buddha Maitreya? No. The Cosmic Christ is simply impersonal and just because this condition he is universal. The Cosmic Christ is Light under Love focusing all beings in all universes, in all planes, in all spheres. The Cosmic Christ resides inside the atom as a meson, congregating protons. He is just the essence of The Force when The Force penetrates the Creation for evaluate it using Duality. Then, if an Adept wants take control on entropic events, he needs in first a profound contact with the Cosmic Christ.

Through this contact with the Cosmic Christ men can understand some aspects of The Force and then can take control on entropic events, generating more bliss in Peace Profound. This is the goal of the Rosicrucian student. Many of them wish this success but only few obtain it. This natural selection is part of the entire process of the authentic Rosicrucian studies and is just because this selection which the Inner Circle is formed in all Orders and Fraternities R+C. When you really knows who are The Force and what The Force does you are qualified for the Inner Circle of your Organization.

Dark Energy and Alpha Structure is not a principle but it is the Third Point of the Mystical Triangle composed with the two principal principles above described. It is necessary that the student understad correctly what isthe Dark Energy.

The Visible Universes (that Universe where Planet Earth and more currently exists) is maintained by a very straight (but thin) structure, called Alpha. This structure is just the support for the Universal Conscience, this that some mystics names of "Consciousness of God", "Cosmic Mind", in a pantheist concept also simply called God.

Rosicrucian students of Superior Degrees know the truth on this matter and also know about Dark Energy. What exactly Dark Energy is? Well, it is just a point of an eternally continuous line (the Line of Existence), that have two other points: Crystal Energy and White Energy. It thus that the Material Plane is manifested, as the Plane of Duality. Alpha Structure is just the conscience of the Plane of Duality, the total conscience of this Plane. Other Planes also exist and all of them are permanently infused by the emanations of the The Force. Examples: Holy Spirit, emanated directly by the Eternal Light, through the Real Central Sun (True Aten); Cosmic Christ, emanated continuously by Crystal Point (the Point Love of the Line of Existence); and Father's Environment (the direct emanation of the True Aten, the real Solar Disk, the Only Creator of Life as human beings know as life).

When this three Points are manifested as a Line, this Line is not a real straight line, but a Circle, and this Circle contains the Time. It is a Minor Circle, relative reflex of the Great Circle, the Absolute Zero, that is the container of Creator, Originator, Creation and all beings. It is the Supreme Circle, the Omnipotent Container, inside it God exist, as Creator and creatures. If a Rosicrucian student intend to know the truth on the human life; if a Rosicrucian student want know what is in reality Eternal Life, the starting point for this student is just the study on the Line. The Line it is not a simple symbol, a mathematical concept for metaphysics constructions: it is much more, it is real, it is the basis of the Creation, the support for all spiritual sciences. Numbers are only a symbol. When I said

that the Absolute Zero extracted Number One from himself as the Creation, consequently creating the Duality, I'm just symbolizing for more human comprehension. But the Line is not a symbolism: it is a curve, a circle, a Circle also (with C in upper case).

Ancient Illuminati have examined the Triangle mentioned here and just on real significance they have constructed the metaphysical structure of Illuminates of Kemet.

CONCLUSION

NOW, into the Great Workmanship for a New World Order based not only in economical and political doctrines, but base in metaphysical principles emated from the Great Central Sun, we are asking people about Seven Crucial Questions, since Year 2000CE. I believe that these questions are fundamental for the New Mental Era deadline, at February 15th, 2034CE and for Novus Ordo Seclorum exactly this metaphysical concept is. Below, once again, the Seven Questions:

The human society has been always unjust, giving privileges to the strong and oppressing the weak. Now more then ever with the economic perverse model, the globalization seams to stimulate the differences between them, which results in thousands dying of scarcity. Corruption, criminality, lies and disaffection are devastating the face of Earth. Models of government from democracy to theology going through utopian socialism, has been showing incapable of solving even general problems of Humanity. We intend to change this picture for the Third Millennium asking to all Rosicrucian the following questions:

1 - Do you think it is possible to establish a universal government on Earth? Not a theoretical entity, but a real and efficient administration capable of legislate and decide in the world level free of pressure from financial groups? In your opinion how this could be done through the next 100 years?

2 - Included in the principal ghosts terrorizing the human race are the nuclear disasters, the demographic explosion, the exhaustion of sources of energy, the lack of sufficient food, ecological pollution, destruction of natural habitats, green house effect, social injustice, the loss of fundamental principals of morals and ethics of the population. How do you think those problems can be solved in a practical manner?

3 - Through the eras cyclic problems has been solved with recycling of values with destruction and reconstruction of constitutive orders. Through wars, as agents of dynamization for such changes. As Rosicrucian do you know any other and better form of action practical and efficient, besides war, to modify the conditions of Humanity as a society for the better and indefinite time?

4 - Which form of leadership would you choose to govern this new human society? In the third millennium?

-A regent to whom all the power would be given, assisted by a highly credited scholars, from all countries.

-A representation of Nations without a central figure to govern.

5 - What kind of code, values and guideline of collective principles would you suggest in order to elaborate a World Constitution, considering all ethnic differences and problems under a global vision?

6 - As for instruction and education of children, how would you design a didactic model? Also for the young/teenagers in order to create a just society capable to offer conditions of mental peace and prosperity enough to inspire the desire to rise at the conscious level of all mankind?

7 - How would you conduct the elaboration of a simple and practical at the same time deep and proficient set of guide lines (rules) to emphasize a canalization of the mystical powers of the people, which actually are focused as religiosity?
